What does the IRAC stand for? The IRAC methodology represents the following concepts of a legal problem: I: The issue or legal matter at hand. R: The rule or expected legal outcome. A: The analysis or explanation of the relevant laws and case law. (Sometimes the "A" is referred to as the "answer," but the content remains the same.)

CRRACC is an elaborated form of IRAC: Conclusion, Rule, Rule Proof, Application, Counterargument, Conclusion. The RR reminds you to state the relevant legal Rule as you have synthesized it from the sources of legal authority (i.e., constitutions, statutes, regulations, and decisional or common law), and then support this rule statement with some organized explanation and discussion of the legal authority upon which the rule statement is based (i.e., the Rule Proof).
